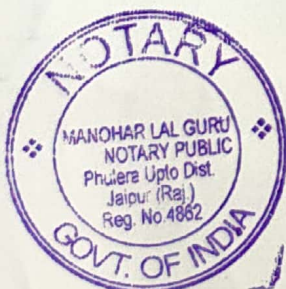

AFFIDAVIT




