Our Patron Saint

St. Anselm came from a noble Lombard family and was born in 1033 AD Aosta in the Italian Alps. His mother was a good and pious Burgundian woman, but after her death his father's violence and harshness finally caused Anselm to flee to France. Here after several years of wandering, he took the Benedictine habit in 1060 at Bee (Normandy), where his illustrious countryman Bl. Lanfrance had started the famous school and soon he was outstanding for his learning. Within three years he was made Prior and after another 15 years, very reluctantly, Abbot.



As abbot, St. Anselm had to cross over to England from time to time in connection with his Abbey's English properties, and there he became known and highly esteemed for his virtues and fearless zeal. So much so that in 1099 he was made Archbishop of Canterbury in the hope that he would be able to cope with the encroachments of King William of England

Many important writings of this gentle Prelate, who was considered the greatest intellectual of his age and a patron for all theologians' were composed during his two banishments. They earned him the title of 'Father of scholasticism' and 'Doctor of the Universal Church' (1720) on account of the deep and lasting influence which his thinking has had upon philosophy and theology.

When the French Capuchin Fathers came to Ajmer they found St. Anselm as the most appropriate saint to be the patron of their new school. They adopted the saint's motto for the school. "DEO AMABILES ET HOMINIBUS" which means: 'Be pleasing to God and to man.' St. Anselm's School, Phulera hopes to make all its students always pleasing to God and fellow men.

Prayer: 'O Lord , our God, Grant us the grace to desire you with our whole heart, that in desiring you we may seek and find you, that finding you we may love you, and loving you we may despise the sins from which you have redeemed us.'

General Information

St. Anselm School, Phulera is one of the many Christian Minority Institutions run by the Gyandeeep Education Society, Jaipur. It is co-educational and imparts education through English Medium. It is affiliated to the Central Board of Secondary Education, New Delhi. The school provides a sound education designed to fit its students for the world of tomorrow, whatever sphere of activity they may be called to.

The aim of the school is to give boys and girls a sound intellectual, physical and moral education so that they turn out to be good and upright citizens for time and eternity. The scholastic year begins in April. The examination pattern will be as per the guidelines given by CBSE.

Reports of conduct, application and progress is issued at the end of each year. The study of Hindi is compulsory in all classes. Drill and outdoor games are compulsory. Regular Parent – teacher meetings are held during the year.

The school offers the following streams at the senior secondary level:

- English, Mathematics, Physics, Chemistry, P.H.E./I.P.
- English, Biology, Physics, Chemistry, P.H.E./I.P.
- English, Accountancy, Business Studies, Economics, P.H.E./I.P.
- English, Accountancy, Business Studies, Economics, Mathematics.
- English, Political Science, History, Economics, Geography, Sociology, P.H.E./I.P.



Admission Procedure

- (i) Admission is open to all boys and girls irrespective of caste and creed.
- (ii) For admission to Nursery, a student must be above 2 years and 9 months old.
A student needs to have completed 3 years 9 months on the 1st April, for admission to LKG. Only those candidates who are between 3 years 9 months and 4 years 9 months are admitted to LKG. Minimum admission age for HKG is 4 years 9 months on 1st April.
- (iii) A corresponding age scale is fixed for the succeeding classes.
- (iv) Only those candidate who are, in the opinion of the Principal, able to follow classes in English, will be considered for admission. Eligible candidates will undergo an interactive session and admission will be granted on merit basis.
- (v) After clearing the written test, the parents should deposit the one time admission fee (non – refundable) to the office within 7 days otherwise the admission rights of the student would be forfeited.
- (vi) The documents required are:
 - Official Birth Certificate from the Municipality / Nagar Palika or the Baptism Certificate (Christians) in support of the date of birth entered in the admission form.
 - Student who has attended any recognized school will not be admitted without a school Leaving Certificate from the same and the Report Card of the Class last attended.
 - 2 passport size photographs of the student. (Not more than 3 months old)
- (vii) Documents submitted for admission will not be returned.
- (viii) Application for admission should be made on the attached registration form.



Withdrawal Procedure

- (i) Before withdrawing a student from the school a calendar months' notice in writing is to be given by the parent or guardian. A month fee is to be paid if no notice of withdrawal is given.
- (ii) Students leaving in April or May must pay their fees for May and June.
- (iii) A Transfer Certificate or any other document will be issued only if all the dues of fees have been paid and all library books returned.
- (iv) A notice of 2 Days must be given for any certificate or official document required from the school.
- (v) If a child has once been withdrawn from the school, the Admission Fee must be paid again on readmission.





Parental Co-operation

- Parents must recognize that they are primarily and principally responsible for the education of their children. It is their duty to create a family atmosphere inspired by love and devotion to God and their fellowmen.
- Parents are requested to study all the Rules of the School Carefully and abide by them faithfully and also have them observed by their children.
- Parents and guardians are not allowed to walk into the classroom or interview teachers during school hours. Those who wish to find out the progress of the child will kindly meet the teachers concerned, with a prior appointment from the Principal.
- Parents are expected to cooperate in the work of the school by enforcing regularity and discipline, and by taking general interest in their child's progress.
- Parents should check the Diary and note the teacher's remark etc. The Progress Report and examination results should be studied by the parents. Remedial measures should promptly be taken.
- Complaints, if any, may be addressed to the Principal or school office directly.
- Every child ought to devote sufficient time for self-study daily.
- The school does not guarantee the success of pupil's studies unless the parents or guardians cooperate with the school authorities and do their part by enforcing regularity and discipline. They must see that they do their home-work and prepare the lessons daily. Let them specially insist on punctuality and regularity in attending the classes. Attendance at school functions is very important.



ATTENDANCE / LEAVE

1. Pupils who have been absent from class must have the reason entered in the Record for Non – attendance stating briefly the cause of the absence. Reasons of a private nature may be submitted in a letter. Absence from school in order to study is not allowed. Leave of absence is not granted except on prior written application from the parent or guardian.
2. Those who come late must have their Late Attendance Record duly signed by the teacher- in – charge in order to be admitted to the classroom.
3. Repeated absence without leave application for more than ten consecutive days renders the pupil liable to have her/his name struck off the rolls. Readmission, if granted, will be done on payment of readmission fee.
4. All the students are expected to be present on the opening day of the school session. A medical certificate must be presented by those absent because of sickness.
5. No pupil is allowed to leave the school premises during school hours. Letters from parents in this regard will not be entertained.

Rule and Discipline

1. On class days and school functions the children are expected to wear the uniform prescribed for the season.
2. Any kind of damage within the school premises must be made good by the one who does it.

Norms of promotion

1. Promotion is decided on the marks obtained throughout the year combined with the marks of the Final Examination.
2. Only pupils who have passed in all the subjects finally have a right to be promoted to a higher standard.
3. Promotions are decided with the teachers concerned and due consideration is given to each student. Hence the results are final and cannot be reconsidered. The School management reserves the right to add or amend any of these Rules and the same shall be binding on the parents and the pupils.
