Dear Parents / Guardians,

The school is in the process of constituting the School PTA and subsequently the School Level Fee Committee (SLFC) of the parents whose ward/s is/are studying in the school during the Session 2021-2022 and propose to study for the academic session 2022-2023. Due to the Covid-19 protocol, the Online procedure will be followed for the said committee.

The parents will be at the liberty to apply in person also with all the required details.

Eligibility / Conditions

- 1. Parents (PTA members) who give their consent through the Google Form using the Link https://forms.gle/esPAHmNwEzYa2gFa7 or written application submitted to the School Office by hand on or before 21 August 2021 will be considered. The written application should reach the School Office by 10 A.M. on 21 August 2021. The last day for Google Form submission is also the same. If the Application is submitted online, there is no need to submit the Hard Copy in the School.
- 2. As per the Act, the application Fee of Rs. 50/- is to be paid Online using the below given details to become a member of PTA:

- Once the payment of Rs. 50/- is successful, Screen shot of the same has to be taken and the Image/PDF has to be uploaded via the Online Form which will be filled by you.
- 4. If applying in person, Rs. 50/- is to be deposited in the bank and a copy of the receipt submitted in the office with the application.
- 5. If the applicant submits handwritten application for PTA/SLFC, then all the relevant details asked in the Google Form should be included in the Application with all the supporting documents.

- 6. The applicant's ward should be a student of the school from Class I to XI or at least is a student admitted from academic session 2020-2021.
- 7. If more than one child is studying in the school, only one application per family will be considered.
- 8. Applicant should have sufficient knowledge about the functioning of the School Systems, Financial matters and the relevant guidelines of the Government on PTA/SLFC related issues.
- The applicant should not be a Fee defaulter in paying fees as on 05.08.2021 in our school records. School Fees mandated by the Honourable Supreme Court verdict concerning Academic Session 2020-2021 should have been complied with.
- 10. The 1st & 2nd Installment School Fees of session 2021-2022 should have been cleared.
- 11. If applying in person submit a printed application on 'A4' Size Sheet with all the supportive Self-Attested copies of the Documents: Aadhar, Last report card of ward, certificate of highest qualification of applicant, Payment receipt of `50/-.
- 12. The Online Form is non-editable after submission and only one chance is permitted. So kindly fill the correct details. In the event of any incorrect information, the application will be summarily rejected.
- 13. In case the number of entries is in excess, the final selection would be done by lottery.
